This 2 hour interactive workshop utilizes video to illustrate team principles and have participants think critically about teamwork in order to consider implementation of new team training initiatives or augmentation of existing programs. Dr. Goffman will address the following questions- What is the role of simulation in team training for interprofessional teams and across disciplines? What are the challenges/barriers and how do we overcome them? How can we practically enforce Team STEPPS through simulation? What are the essential components of a successful team training program? How can we tie team training to patient outcomes/improved quality and safety?

Biography—Dr. Dena Goffman

Dena Goffman, MD, graduated from the Albert Einstein College of Medicine and completed her residency in Obstetrics and Gynecology at New York Presbyterian Hospital/Columbia University Medical Center.

Dr. Goffman went on to complete a fellowship in Maternal Fetal Medicine with additional training in Critical Care Medicine at Albert Einstein College of Medicine/Montefiore Medical Center.

Dr. Goffman is currently an Associate Professor of Obstetrics and Gynecology & Women's Health at Albert Einstein College of Medicine and Director of Maternal Safety & Simulation at Montefiore Medical Center. She has a strong interest in improving patient safety and quality in obstetrics. Much of her work focuses on the use of simulation, team training and implementation of evidence based guidelines to achieve this goal. She serves as the Chair of the Quality Improvement Committee for Obstetrics and is a member of the Physician Quality Leadership Group at Montefiore Medical Center. Dr. Goffman has been an active member of the New York State-Department Of Health and The American Congress of Obstetricians and Gynecologists District II Safe Motherhood Initiative, as a Maternal Mortality Reviewer, a member of the Critical Care Sub-Committee, co-chair of the Hypertensive Disease and Pregnancy Sub-Committee and frequent lecturer. More recently, she became a steering committee member for the new NYS SMI endeavor, as well as Co-chair of the Obstetric Hemorrhage group for this state-wide program. Additionally, she is active nationally and internationally as a Simulation Subcommittee Member for the Society of Maternal Fetal Medicine, former Co-chair of the OB-GYN Special Interest Group for the Society for Simulation in Healthcare and faculty for the ACOG ACM Obstetric Emergency Simulation Course.
