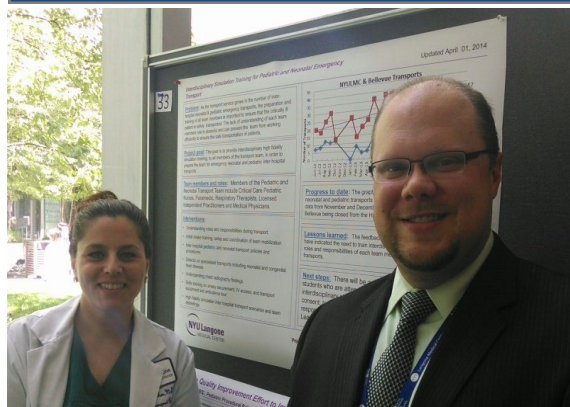

Jason Konzelmann, Administrative Supervisor at NYSIM and Renee Sanchez, RN, MSN, Pediatric & Neonatal Program Coordinator, presented the a poster on “Interdisciplinary Simulation Training for Pediatric and Neonatal Emergency Transport” during the 6th Annual Quality & Safety day poster session at NYULMC. The poster highlighted their hard work in providing hands-on simulation-based education programs to the multi-professional members of the transport team which includes critical care pediatric nurses, physicians, licensed independent practitioners, respiratory therapists, and paramedics.

Jason and Renee worked with an interprofessional faculty team to develop this program to practice the clinical management of critical care pediatric patients during emergency transport with an emphasis on high quality teamwork and communication across the health professions.
