Her current funded research is in service-learning/community engagement and peer mentoring in PhD students.

She is the Co-Chair of the American Academy of Nursing, Raise the Voice Campaign Committee of Sigma Theta Tau National Honor Society of Nursing Building Corporation Committee and an appointed faculty member to the STTI Experienced Nursed Faculty Leadership Academy. She is the immediate past President of the Alpha Phi Chapter, Sigma Theta Tau International Honor Society of Nursing at Hunter College

She is an elected fellow of the American Academy of Nursing, fellow of the National Academies of Practice and a fellow of the New York Academy of Medicine. She is the 2015 recipient of the National League for Nursing Mary Nutting Award for Outstanding Teaching or Leadership in Nursing Education

Dr. Nickitas earned a B.S. in Nursing from SUNY Stony Brook University, a M.A. in Nursing from New York University, and a PhD in Nursing from Adelphi University.
